The Government Structure



What we do

The purpose of the Australia Council is to champion and invest in Australian arts.

The Council's role:

- national advocate for the arts
- supporting excellence and diversity across all art forms
- increasing national and international engagement with Australian arts
- building a vibrant and sustainable arts ecology across its programs.

The Council's programs include:

- grants for artists and arts organisations to create, develop and present their work
- government directed initiatives and frameworks
- strategic research and analysis to build the evidence base for the arts
- market development and capacity building activity



Activity

- Australia Council's 2014 2019 strategic plan: A Culturally Ambitious Nation
- Holistic and streamlined grant programs to support individual artists, groups and organisations
- Four Year Funding for arts organisations of significant regional, national or international standing from 2017
- Administering funding to 28 companies under the Major Performing Arts Framework
- Research and evaluation to increase the evidence base for the arts, inform policy development and promote a national conversation about arts and culture
- Aboriginal and Torres Strait Islander Arts initiatives
- Strategic national and international development to meet the needs and priorities of the arts sector
- Capacity building programs for arts leaders and organisations

Australia Council Review 2012

"The Review recommends that a new model for grant allocation be implemented that: a) Replaces the standing Artform Board structure with a general stream for grant applications across all artforms; and b) Maintains the centrality of peer assessment but promotes flexibility and breadth by [allowing] for more peers to become involved in assessment and thereby diversifying the mix of peers."

Four Year Funding

- Multi-year funding an important component of Council's grant program
- Each iteration of multi-year funding is a new process, not a continuation of current arrangements
- All arts practices assessed at the same time for consistency
- Four Year Funding is not the best fit for every organisation
- We currently invest approximately \$28m per annum in 124 FYFOs



Four Year Funding

- Multi-year funding for arts organisations with a compelling four year vision
- Organisations delivering artistic programs or services for the arts to a high standard
- Organisations registered under Australian law, or created by law
- Requests of \$100,000 to \$500,000 per year
- Two-stage application process



Career Development Grants

- Not offered by all artform areas prior to 2015
- More opportunities for access open to early career, mid career and established artists and arts workers
- Activity includes residencies, research and development, conferences and meeting attendance
- Up to \$25,000
- Fellowships and Awards also available for established artists

Two important principles guide how funding is allocated through our grants model

- Decisions are made at arm's length from Government
- Grant applications are assessed by peers with arts expertise, who consider the merit of applications against published criteria in competition with others
- Our assessment model up to 30 June 2013 comprised
 - Artform Boards and peer advisors
 - Peer assessment panels
 - Average scores, standard deviations





- Deliberative decision making
- The decision making standard is the merit of the applications in responding to the published selection criteria
- The decision making method is mutual agreement, based on reasoned arguments put forward by peer assessors





- 5-10 experienced peers on each panel
- Diverse representation across
 - Genres of arts practice
 - Artistic roles and experience
 - Geography
 - Cultural background
 - Gender
 - Disability
 - Age





Flexibility, Breadth & Diversity

Between May 2014 and April 2017, **647 individuals** peer assessed Australia Council grants

- 24% were from regional or remote areas
- 16% identified as Culturally And Linguistically Diverse
- 17% identified as an Aboriginal or Torres Strait Islander
- 5% identified with disability
